The service should be provided to the Ministry of Economic Development of Georgia and its territorial bodies – registration of state property and privatizations, according to the regulations of the regional administration until the end of 2009.

Late qualification data will not be discussed by the committee.

The qualification data should satisfy following requirements:

**Juristic Persons:**

- The juristic person's properties should not have any public-legislative limitations registered (notice from the public registrar's national agency.)
- Should not be subject of payment aptitude investigation (notice from the court of law), reorganization or liquidation (notice from corresponding bodies.)
- The juristic person should not be the subject of criminal case investigation concerning their career activities (notice from the Ministry of Internal Affairs.)
- The tender documentation should include personal information: address, tel. number/fax, bank requisites, name of the manager.
- Notice from the audit council of the parliament concerning registration.

- Copies of the qualification certificates from the audit council of the parliament.

**Physical persons:**

- Must be efficacious (notice from authoritative institutes.)
- Should not be the subject of criminal case investigation concerning his economic and career related activities (notice from the Ministry of Internal Affairs.)
- The tender documentation should include personal information: address, tel. number/fax, bank requisites.
- Copies of the qualification certificates from the audit council of the parliament.

**Additional requirements:**

- Notice that the person does not owe any money to the budget (tax inspection)
- Information about similar activities within last 2 years.
- Information about payment forms and requirements.
- Together with the tender offer, the applicant must present the price of the required service in percentages compared with the price of the property.

The tender offer and contract obligation maintenance mechanism won't be used.

The applicant who submits fake qualification papers or papers that do not fulfill the requirements will be disqualified.

The applicants should pay a fee - 200 Gel before submitting the documents on the following account:
