4. Conclusions:

1. To provide further communication of the National Agency of Public Registry (NAPR) and the Georgian Microfinance Association with the National Agency of taking into the issues discussed at the meeting within the presentations suggested by the National Agency of Public Registry and the Georgian Microfinance Association concerning the need for both current and future development of additional professional skills and retraining of personnel required in the process of activities carried out by the Agency and the Microfinance Association.

2. Pursuant to the interest expressed at the meeting by the private sector regarding the implemented programs, ongoing banking regulations, news and activities planned by banking and microfinance organizations, to make a communication with the Banking Association to provide a presentation on the mentioned issues at the session of the Council;
3. In accordance with the request of the NAPR, member associations of the Council was requested to disseminate the information to their member companies about the ongoing process of re-registration of entrepreneurial entities in the Business Registry and the urgency to comply with the third extended deadline (until April 2026) for the process;
4. To establish further cooperation between NAPR and Microfinance Organization on the ongoing simplified land registration process, which considers the association's communication with its beneficiaries, especially at the regional level, on the above, including the dissemination of information on the possibility of conducting the land registration process online.
